

RANGE RULES, REGULATIONS & WAIVER OF LIABILITY FOR SILVER CREEK RANGE, LLC.

In consideration for receiving permission to participate in SILVER CREEK RANGE. LLC:

1. I hereby release, waive, discharge and covenant not to sue/institute legal and or civil proceedings against SILVER CREEK RANGE, LLC, its officers, servants, agents, employees, members, guest(s) or participants (hereinafter as “**releasees**”) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or relating to any loss, damage or injury, including death, that may be sustained by me or my guest(s), or to any property belonging to me or in my control, whether caused by the negligence of the **releasees**, or otherwise, while participating in any activity at SILVER CREEK RANGE, LLC or upon the premises.
2. I am fully aware of risks and hazards connected with being on the premises and participating in any activity at SILVER CREEK RANGE, LLC and I am fully aware that there may be risks and hazards unknown to me connected with being on the premises and participating in any activity at SILVER CREEK RANGE, LLC and I hereby elect to voluntarily participate at SILVER CREEK RANGE, LLC and engage in activities knowing that conditions may be hazardous, or may become hazardous or dangerous to me and my property. I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death, that may be sustained to me or my guest(s), or any loss or damage to property owned by me or in my control, as a result of me being a participant or at SILVER CREEK RANGE, LLC whether caused by the negligence of **releasees** or otherwise.
3. I further hereby agree to indemnify and save and hold harmless the **releasees** and each of them, from any loss, liability, damage or costs they may incur due to my participation in any activity or while on the premises at SILVER CREEK RANGE, LLC whether caused by the negligence of any or all of the **releasees**, or otherwise.
4. It is my express intent that this Release shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a Release, Waiver, Discharge and Covenant Not to Sue/institute legal and or civil proceedings the above named **releasees**.

In signing this release, I acknowledge and represent that:

- A. I have read the foregoing release, understand it, agree with it and sign it voluntarily as my own free act and deed.
- B. No oral representation, statements or inducements, apart from the foregoing written agreement, have been made.
- C. I am at least eighteen (18) years of age and fully competent, or I am under the supervision of a fully competent adult or I am the guardian of said guest.
- D. I execute this Release for full, adequate and complete consideration fully intending to be bound by same.

SILVER CREEK RANGE, LLC RULES & REGULATIONS.

1. It is MY RESPONSIBILITY to keep myself and everyone safe.
 - Handle every firearm as if it is loaded.
 - Keep your finger off of the trigger and outside of the trigger guard unless you intend to shoot.
 - Always keep the firearm pointed in a safe direction.
2. "CEASE FIRE" means... STOP SHOOTING, make your weapon safe, place it on the shooting table or into your holster and step back from the firing line.
3. Anytime that you observe a potentially unsafe condition developing, it is my responsibility to immediately call "CEASE FIRE" and correct the matter. "SEE IT SORT IT."
4. Be courteous and mindful of your time on the range if others happen to be waiting.
5. No alcoholic beverages, illegal narcotics or persons who are under the influence of those items will be allowed on the range or premises. If taking prescription medication please notify range staff prior to engaging in activities while on the range/property.
6. All guests of Range Members MUST stay with the Range Member at all times. You, as a Range Member are responsible for the guest(s) you bring and also responsible in relaying the range rules and regulations to said guest(s). You must also drive your guest(s) in your vehicle onto the range property. Your guest(s) is not allowed to drive their own vehicle onto the range property nor park directly outside of the gate.
7. Shooting glasses or tempered glasses/lens and hearing protection must be worn at all times while inside or around the firing area. Wearing a ball cap is recommended. Open toed shoes are not recommended. Electronic hearing protection is also recommended. *These will not be supplied.*

8. Approved hearing protection must be worn at all times when on or near the firing line. Approved electronic hearing protection is required while participating at the 1,000 yard range.
9. Live shooting with suppressed firearms and subsonic ammo only is permissible before 8AM and at paper targets only. After 8AM live shooting while unsuppressed or other than subsonic ammo and at steel targets is permissible. Hours are sunrise until 30 minutes before sundown. In other words, DO NOT MAKE NOISE BEFORE 8AM.
10. Firing at night/after dark is not permitted unless participating in a scheduled/explicitly authorized “night fire” event supervised by authorized range staff.
11. Before actively shooting on Range 1. (the 200-1,000 yard range) all members and guests must first sight in/verify zero on Range 8. Once verified then proceed to the 200-1,000 yard range (Range 1) and progressively step out to the 1,000 yard target by starting at the 200 yard target. If have properly sighted in no fired round should ever be further than 12” from your intended target. Furthermore, no round should ever leave the range if you properly follow procedures. If you are missing the intended target on any range or can not spot your shots then stop shooting and properly bore sight your rifle before proceeding.
12. Before firing at any target or while at any range you and your guest(s) must visually scan the entire range you may be occupying to ensure no one is down range and the range is clear.
13. Before proceeding down range, for whatever reason, on the 1,000 yard range (Range 1) you must temporarily close this range by hanging/displaying the “RANGE CLOSED” signs that are provided. You must also hang your membership lanyard on one of the “RANGE CLOSED” signs before proceeding down range. You must also activate the two provided red strobe/blinking lights by turning on the on/off switch. By hanging the RANGE CLOSED signs and activating the blinking lights you are activating a redundant safety system letting others know that you are down range and or the Range 1 is closed. If you have temporarily closed the range with the “RANGE CLOSED” signs you must then secure the signs and turn off both lights before departing for the day. Leaving the “RANGE CLOSED” signs out on display and not securing them or not turning the lights off before departing the range pr travelling to other rages on the property may result in a \$50 fine, immediate suspension or permanent ejection from Silver Creek Range. Also, not displaying/hanging your membership lanyard from the “RANGE CLOSED” sign may result in a \$50 fine, immediate suspension or permanent ejection from Silver Creek Range.
14. When someone is down range do NOT touch your firearm!

15. Children must be supervised at all times while on the premises. Persons under the age of 18 must be accompanied by their parent or guardian and supervised at all times. However, we do encourage young people become active within the range and shooting sports.
16. Shotguns NOR handguns are permitted to be used on Range 1.
17. If going down range on Range 1 you must drive. Walking to any target on Range 1 is not permissible.
18. Do not aim at or shoot anything other than designated and approved targets.
19. All steel targets that have been knocked down and or shot must be returned to their position and repainted before leaving the range unless adverse weather conditions arise, like rain, that prevent you from doing so.
20. No armor piercing, steel core, steel jacket, tracer, explosive ammunitions, exploding targets or tannerite type products will be allowed.
21. No steel shotgun pellets or steel bb's shot at ANY steel targets.
22. Do not shoot the "Rubber Dummy" targets with any ammo but ball/FMJ ammo. No hollow points, wad cutters/semi wad cutters to include shotgun ammo of any kind.
23. Recommended shooting distance(s) for AR500 Steel Targets:
 - .22 rim fire pistol, 9mm, .38spl – 8 yards.
 - .357 pistol, .40S&W, .45Colt, .44spl, .45ACP, .44mag pistol, .22 rim fire rifle – 12 yards.
 - .357 mag rifle, .45 colt rifle, .44 mag rifle, .22 rim fire rifle, 7.62X39, 30-30, 45-70 – 100 yards.
 - .308, .30-06 – 150 yards.
 - 7.62X54, .223/5.56, 270 win – 200 yards.
 - .22-250 – 300 yards.
 - 300 win mag – 400 yards.
 - Shotgun w/lead bird shot – 12 yards.
 - Shotgun w/std velocity 00 lead buck shot – 20 yards.
 - Shotgun w/std velocity lead slug – 50 yards.
 - Shotgun w/std velocity lead sabot slug – 100 yards.
24. All unboxed/opened/unpacked/displayed/un-holstered firearms not actively firing must contain and display a chamber flag and or actions/bolts/slides opened, locked to the rear and pointed down range.

25. No person will be allowed forward of the firing line until you make it clear to other shooters/members/guests that the range is “cold”.
26. When a range is HOT that means a particular range is active or that there are active shooters conducting live fire on that particular range.
27. When a range is COLD that means a particular is not active or that there are no active shooters conducting live fire or that personnel are down range on that particular range.
28. When proceeding down range past the 600 yard targets on the 1,000 yard range you must utilize the road to the RIGHT only. The same road is to also be utilized upon returning. Do not cut through the grass to the right/West.
29. No targets are to be placed BEFORE 200 yards on the 1,000 yard range.
30. No targets are to be placed on the road adjacent to the 1,000 yard range.
31. Before proceeding down range be sure to verbally communicate to others that they understand and verbally acknowledge that you are proceeding down range.
32. NO CROSS FIRING!
33. Only firearms in good working condition are allowed on the firing line. (user is held responsible)
34. All fired rounds must impact the bullet trap/berm area. No shooting into the dirt/ground or skipping rounds over the berm.
35. No target is to be placed or added to the range where if the target is missed or penetrated through a projectile/bullet would not strike a berm area.
36. No target is to be placed or added to the range ON THE GROUND where if the target is missed or penetrated through would cause a projectile/bullet to “skip” over a berm area.
37. All firearms and equipment are subject to inspection at any time by range staff.
38. All firearms must be pointed down range in a safe manner while at the firing line.
39. Range Members must wear or have visible on their person or in their vehicle hanging from the rearview mirror, their assigned Range Member lanyard and membership ID while on the range/property. Please alert range staff if you observe someone without membership ID or who is not an obvious guest(s) of a range member. Range members are subject to being challenged by any other

- range member while on premises or entering the premises to see if they have their membership identification.
40. Range members are required to write their emergency contact and blood type on the back of their range membership card.
 41. All DOT protective gear must be worn by operators and or passengers if operating any off-road type vehicles such as four wheelers or side by sides but not limited to.
 42. All vehicles must stay on designated roads, parking areas and bridges/creek crossings designated by range staff. We are not responsible or liable for stuck/disabled or damage that may occur to your vehicle while on range property.
 43. Utility trailers or alike are to be parked in the staging area near the shipping container and range equipment. Do not park a trailer or like in a range area or in front of a live firing line. If you have a trailer longer than 15 feet long you must first have range staff permission to bring onto the property.
 44. NO SMOKING!
 45. All shell casings must be picked up after firing or before departing the range and placed into the designated red buckets. DO NOT THROW SHELL CASINGS OF ANY MATERIAL, ESPECIALLY BRASS, INTO THE GARBAGE CANS.
 46. No food containers or food items or anything that had food in it are to be placed into the designated garbage cans. Do not leave trash behind yourself or your guest(s). Clean up after yourselves!
 47. If you experience or observe a steel target malfunction or breakage immediately call a ceasefire and notify me, Jeff Stone @ 251-422-9641. Fallen, broken or improperly angled steel targets could possibly cause an unintentional bullet deflection. Steel targets that cannot be immediately repaired or properly re-hung must be immediately removed from the range and put into the shoot house from the range where they came. If you cannot pick up or remove said target from the range the said target must be temporarily placed behind the berm so it does not get shot. Either way, you must then call Jeff Stone @ 251-422-9641.
 48. Wildlife/game on range premises must not be fired upon nor maliciously disturbed. Hunting is only permissible if express written permission is given by the range owner, Jeff Stone.
 49. Gopher tortoise(s), if encountered, or their burrows, must not be disturbed in any manner. Any sightings of gopher tortoises must be immediately reported to range staff. Gopher tortoises are known to be in the area and are an endangered species.

50. You and your guests are aware that there are poisonous snakes on the entire range property. You and your guest(s) also understand that the range owner, it's employees nor members or guests of the range are, in any way, responsible nor liable if you get bit by a snake while on premises.

51. Any violation of above listed, but not limited to, may result in a \$50 fine, or permanent suspension, or temporary suspension or permanent termination of range usage, without refund, depending on the violation(s).

52. I understand and agree that any and all activities while on premises whether involved with directly or indirectly or simply being on premises at any time is AT MY OWN OR MY GUEST'S OWN RISK AND THAT DEATH OR SERIOUS BODILY INJURY MAY OCCUR . By being on the property/Silver Creek Range you agree to these terms if you are member or guest and will not hold it's owners, nor employees nor members nor guests liable for anything that could happen on the range.
